#### THE WHIPPLE FAMILY

#### **ESSEX**

Research to trace the English ancestry of John Whipple who emigrated to America in 1632 commenced on the basis of the following information:

Captain John Whipple is thought to have been born in the parish of Bocking, Essex, in about 1616/17. However the registers of Bocking contain several gaps, and John's baptism is assumed to have been lost. John is thought to have been related to Matthew Whipple, a clothier of Bocking. It is known from the surviving registers that Matthew had children Anne, Margaret, Johane, Elizabeth, John and Amy baptised 1583-1605. Others of his children whose baptisms do not appear in the Bocking registers were Matthew junior, born circa 1590, Jane born circa 1592 and Mary born circa 1599. Both Matthew junior and John married, Matthew to Anne Hawkins and John to Sarah Hawkins; and both had sons named John. John, son of Matthew, was born in about 1632 and became known as Lieutenant John; and John, son of John, was born in about 1625 and became known, like the ancestor, as Captain John. There has therefore been some confusion between the two Captain Johns, who are, nevertheless, thought to be related. Both Matthew and John senior are said to have arrived in America in 1638. John the ancestor arrived there aged 15 or 16 in 1632, and is said to have been apprenticed to a carpenter, Israel Stoughton, in order to obtain passage, sailing on the ship 'Lyon'. He subsequently married Sarah They or Darling in about 1639, and died in 1685.

Our first search was of printed emigrant sources for Whipple references. The first was Winifred Ashwell's Essex & The Lyon. This gave the information that the 'Lyon', with its master Captain Pierce, sailed from London on 2 June 1632 and arrived in Boston on Sunday 16 November 1632. According to the records the ship contained some 60 men and 50 children, as well as women. Amongst the listed passengers were a Matthew Whipple and John Whipple, carpenter. The 'Lyon' was

owned by the Vassall family of Eastwood, Essex. John Vassall, a merchant and member of the Virginia Company of London, was also a neighbour of John Winthrop. The evidence for the Essex origins of the passengers is given in the names they gave to their settlements in America: Billericay, Braintree, Dedham, Coggeshall, Wickford and others. In all the passengers are said to have come from the following Essex villages: Braintree, Bocking, Boxted, Bures, Castle Hedingham, Fourstead or Leighs, Dedham, Nazing, High Laver, Ongar, Stisted and Great Bromley.

Banks' Planters of the Commonwealth refers to a John Whipple of Bocking, Essex, settling in Dorchester. However, he appears to give the date of John's arrival as 1630, among the Winthrop fleet which sailed that year, although Banks states that John was only presumed to have been on one of these ships. Banks' Topographical Dictionary of 2885 English Emigrants to New England 1620-1650 lists a Matthew and John Whipple from Bocking settling in Ipswich, Massachusetts.

Passengers to America edited by Michael Tepper lists a John Whipple as a first settler of Rhode Island in 1636. This list was compiled by John Farmer.

In <u>Founders of Early American Families</u> by Meredith B Colket Jr (1975), among details of emigrants from Europe 1607-57, we found references to three Whipples:

 John Whipple, in Dorchester Massachusetts 1632, Providence 1659, died there 1685. Agent for Mr Saltonstall, captain, tavern keeper

- John Whipple, of Ipswich Massachusetts. Died there 30 June 1669 Brother of Matthew, deacon
- 3. Matthew Whipple of Ipswich Massachusettts 1638. Died there 28 September 1647. Deputy Deacon, brother of John of Ipswich.

It was apparent that John (1) was the ancestor, as he received a grant of land in Dorchester in 1637. The information from these sources suggests that Matthew had arrived on the 'Lyon' with John the ancestor in 1632 rather than in 1638; and Matthew's brother John arrived in 1638.

The next step was to examine the original registers of Bocking, covering the years 1575 to 1632. All Whipple entries found are given in the appendix to this report on pages 1-2. As expected, there were many gaps in the registers. Baptisms are missing 1571/2-1581/2 and 1606-55. However, the baptisms of six children of Matthew the clothier were identified, and these agreed with the transcripts made of the surviving registers by J J Goodwin:

20 Jan 1604 Amy Whipple daughter of Matthew

The marriage registers were missing 1575-92, but the marriages of all but one of these children were found, as well as the marriage of a daughter Mary in 1625. The marriage of Matthew Whipple to Ann

Hawkins in 1622 was noted, but not the marriage of John Whipple to Sarah Hawkins. Turning to the burial registers, we noted the burials of Matthew the clothier and his wife Joan in 1612 and 1618/19. The burial registers also provided evidence of other children of Matthew and Ann Hawkins. They had two sons named Matthew buried in 1623 and 1627. Matthew's brother John must have married by 1625 as the burial registers show the burial of his son John.

# 4 Aug 1625 John Whipple son of John Whipple

This entry was interesting as our information had been that the "second" Captain John, eldest son of John, was born in 1625. In this case John senior would have had another son John born after or shortly before the death of the first child. Unfortunately this could not be confirmed as the baptismal registers are missing, and, as with most Essex parishes, there are no Bishop's Transcripts surviving for Bocking. These are contemporary copies made by the incumbent for the diocesan records.

It had been indicated that Matthew the clothier, who died in 1618/19, left a will proved in the superior probate court, the Prerogative Court of Canterbury. We now examined this document in the hope that it would provide a clue to the origins of the ancestor. The PCC indexes were searched 1580-1620 for any Whipple wills, but Matthew's was the only one found. The details of this will are given on pages 4-5 of the appendix to this report. He

mentioned his children Matthew, John, Jane, Elizabeth, Mary, Amy, Anne and Joane; and his grandchildren Hercules and Margaret Arthur and Henry and Anne Caldham. Also mentioned was Matthew's sister, wife of Richard Rathbone. There was however no clue to the origins of John the ancestor.

Our next step was to turn to the International Genealogical Index of Essex. This is an index to baptisms and marriages, compiled by the Church of Latter Day Saints and arranged alphabetically by county. It is neither complete nor wholly accurate, but is a useful genealogical source. On the IGI we found the baptisms said to have taken place at Bocking, including, as we had suspected, the baptism of a second John, son of John, in December 1625, as well as other children of John and Sarah:

Although the IGI does not list burials, a symbol indicates if it is known that the child died before the age of eight. Five of John's children were shown thus: Ann, the first John, Judith and both Matthews.

However, the source of this information on the IGI was not the original registers of Bocking, but had been submitted to the Church of Latter Day Saints by a member of this church; the actual reliability of the information must therefore be suspect unless it can be verified. Nevertheless, the fact that no baptisms are indicated after 1637 does tend to confirm that he emigrated in 1638.

The IGI also contains an unverified entry for the baptism of a John, son of Matthew, in 1617:

16 May 1617 John s Matthew Whipple

No place is given for this birth/baptism, and again the source was private information submitted to the compilers. It is often found that these sources are nothing more than family tradition, or are based on ages or other information given at death. This therefore cannot be accepted as proof of the birthdate or parentage of the ancestor. It cannot refer to Matthew clothier of Bocking, who died in 1612; nor to his son Matthew, whose son John (Lieutenant John) was born in 1632.

It had been suggested that John the ancestor was apprenticed to an Israel Stoughton of Bocking before he arrived in America. We checked Essex apprenticeship records, but none survive from this period for Bocking; the surname Stoughton does however appear occasionally in the Bocking registers, although no reference was noted to the forename Israel.

It was now apparent that no further clues to the origins of the ancestor would be found in Bocking, and the search was widened for Whipple and variant entries in other parishes. First of all we searched the registers 1600-35 of parishes immediately surrounding Bocking: Gosfield, Shalford, Stisted, Rayne and Halstead. Those of Braintree do not begin until 1660. Unfortunately no Whipple entries were found in any of these parishes.

Before 1858 wills were proved, and administrations of estates of intestates were granted, by the local ecclesiastical courts. The indexes of the local probate courts of Essex contained eleven Whipple etc wills proved 1400-1700 (See Appendix page 6). Details of each were abstracted (pp 7-19), hoping to find a reference to Whipples living in America in a will proved after 1632. Four wills were made after this date: James Whaples of Colchester, William Whaples of Great Waltham, Ellen Whaples of Colchester and Thomas Whaples of Great Waltham. Nothing helpful was found. The earlier wills, while obviously not likely to refer to relatives in America, might, it was hoped, identify families likely to be related to John the ancestor. Of these, the will of Edward Whaples of Eastwood, proved in 1610, was

of most interest. He named a brother John, but more significantly, the will was witnessed by a John Vassall. We know that the Vassall family of Eastwood were the owners of the 'Lyon'; Edward did not say where his brother John lived, or whether he had children. The will of William Whaples of Margaretting, dated 1618 and proved 1627/8, was interesting in that it mentioned his nephew John, son of William's brother Robert. Agnes of Margaretting (1627/8) is probably William's widow, but does not mention Robert and John.

None of the wills examined had mentioned the Bocking family, and in no will was the name spelled as Whipple. However, spelling was not standardised at this time and even highly-educated people spelled their own names in a variety of ways.

We had now identified several people who could have been the father of, or related to, the ancestor; but had found no proof that he was closely related to the Bocking Whipples. The next step was to examine further parish registers for the baptism of John Whipple in about 1617. To aid the identification of likely parishes, we first listed all Whipple/Whaple marriages in Essex contained in Boyd's Marriage Index. This index, which is arranged by county, lists English marriages from the commencement of parish registers in 1538 to 1837. Nineteen such marriages were found from Essex, seven of which referred to males before 1618 (p20):

The entries for the parishes of Tollesbury, South Weald,
Chelmsford and Felsted were interesting, and we also wished to
examine the registers of Margaretting, Eastwood and Great Waltham.

The registers of South Weald were checked 1600-25, but only contained the marriage of John and Tomasyn, again with no surname given for the bride. Margaretting registers were found to survive only from 1627 for baptisms and burials, and 1628 for marriages. Eastwood registers survive from 1685 and 1686 onwards. This was disappointing in view of the interesting wills. The Felsted registers 1600-25 contained only the marriage of William Whaples and Ann Lilford in 1609. The registers of Chelmsford, again examined 1600-25, contained not only the marriage of John Whapells to Joane Dale in 1604, but the baptisms of children Thomas, Joan and Richard 1604-10; the son Richard was buried in 1611, and John himself was buried in 1615, so could not have been the ancestor. The registers of Tollesbury 1590-1625 contained several Whaple entries (p 21). A John, son of Robert and Susan, was baptised in 1624/5, but this is

obviously too late to refer to the ancestor. A John Whaple, probably the child's father, was buried a year later.

The registers of Great Waltham were examined 1600-25 revealed the following baptism (p 22):

13 Dec 1618 Joh(ann) is Whaples fil: Joh(ann) is

A brother William was baptised in 1620. John Whaples married Mary Collet in 1617/18, and was probably the son of William Whaples, whose daughter Judith was buried in 1601 and who died himself in 1602. We took the search of the Great Waltham registers up to the end of 1650 (Appendix p 23) and found that John had another son, Robert, baptised in early 1630; he seems to have died in 1638.

The William Whaples who died in 1602 is the man whose will, proved in the same year, we had previously abstracted (pp 11-12); he had sons William, John and Robert and a wife Margaret, whose burial was noted in 1635. His son William left a will proved in 1645 (p 16), which mentions his brothers Thomas and Robert and his widowed mother, but not his brother John. Thomas Whaples had daughters Rebecca and Mary baptised 1647-9, and died in 1689. His will (pp 18-19) does not mention any of his brothers.

William (1645) did not mention his brother John, baptised in 1618, which implies that he had either died or, perhaps, gone abroad.

It was interesting to note that John Whipple, the emigrant, named his son William.

William and Margaret Whaples of Great Waltham who died in 1602 and 1635 therefore had three known sons: William, John and Robert His son John had four sons: John (1618), William (1620), Robert (1630) and Thomas. Of these sons, William left a will proved in 1645, and Thomas had children baptised 1647-9; Robert was still living in 1645, as was their mother. As their father John seems to have died by 1645, we may assume that he was the John Whaples buried in 1638. The child John does not seem to have died in infancy, and the fact that he was the only brother not named in William's will does indicate that he could well have been the ancestor.

Returning to printed sources, we examined the Lane family papers recorded in the New England Register, but these mainly refer to the period 1650-90. Other references are to the Whipple family of Norfolk, and details are included in the appendix to this report. The Bocking family is believed to have originated in Norfolk or Suffolk, and we checked the International Genealogical Index of these counties for any Whipple entries. None of any significance were found in Suffolk, but the Norfolk index contained references to the family found in printed sources. No link has yet been found between the Essex and Norfolk families.

In conclusion, we have not so far been able to prove that John Whipple who arrived in America on the 'Lyon' was a member of the Bocking family. It could be a coincidence that he emigrated at the same time as Matthew of Bocking. The baptism of a John Whaples at Great Waltham in 1618 does more or less agree with our information that the emigrant was aged 15 or 16 in 1632, but further research is necessary to prove that this was the ancestor, and to try to determine any connection with the Whipples of Bocking. The fact that most Whipple/Whaples families have been found in a close cluster of parishes around Bocking, Felsted and Great Waltham, and that William of Great Waltham had property in Felsted and Margaretting, does indicate that the families were probably connected. Any further research would commence by looking for Whipple/Whaples wills later than 1630 proved in the PCC, and also for Collet wills, this being the maiden name of the mother of the John baptised in 1618. We noted that Mary Collet/Whaples' son Thomas mentioned his "mansion house called Collets" in Great Waltham, so Mary Collet's family seem to have been fairly wealthy, and thus are likely to have left detailed wills. We would hope that one of these would mention their grandson or nephew John, and possibly tell us whether or not he survived childhood, and, if he did, whether he settled in England or went abroad.



The accompanying pedigree will show the connection between the Reyners, Lanes and Whipples.



Much confusion has arisen about the last named family, since there were three Johns living in Ipswich at the same time, viz.: John, senr., his son, and his nephew. I believe the following abstracts found among the Lane papers will harmonize all differences.

7th, 10th mo., 1652. John Whipple writes to son Lyonwell Worth at Salisbury, mentioning "your brother John, your daughter Susan, your wife and daughter Mary who should be weaned."

April 3, 1682. John Whipple writes son John Lane, and the postscript

is written by E. Whipple. "Son Joseph unwell, &c."

May 29, 1682. E. Whipple writes to loving son John Lane and wife. Date unknown, (1690?). John Lane writes brother John Lane and wife announcing death of brother Joseph on the eleventh May. "Uncle and aunt Stone are with us, &c."

Mary Belcher writes her loving cousin Susanna Whipple.

Rev. John Reyner's will, dated April 19, 1669, was proved June 30, 1669. His second wife was Frances Clarke (see Felt's Ecc. Hist. of New Eng. p. 497), by whom he had John, Elizabeth, Dorothy, Abigail and Judith. This Judith no doubt married Rev. Jabez Fox of Woburn, Mass., for John Lane mentions uncle Fox as acting as amanuensis for Job Lane, and there is a deed already given in this publication, witnessed by Jabez and Judith Fox.

Gov. Bradford in his History (p. 351) gives the following sketch of Reyner:—"And it pleased the Lord to send them an able and a godly man, (Mr. John Reinor,) and of a meeke and humble spirite, sound in ye truth, and every way unreproveable in his life and conversation; whom, after some time of triall, they chose for their teacher, the fruits of whose labours they injoyed many years with much comforte, in peace and good agreemente." By his first wife, —— Boys, he had issue, Jachin, and Hannah wife of Job Lane; by his second, Frances Clark, he had John, who m. Judith, dau. of Edmund Quincy, Elizabeth, Dorothy, Abigail and Judith. Judith no doubt married Rev. Jabez Fox, of Woburn, and 2d, Col. Jona Tyng, and d. June 5, 1736, aged 98. Elizabeth married Thomas Southworth, (son of Edward S., by Alice Carpenter, who m. secondly, Gov. Bradford,) and had an only child, Elizabeth, wife of
