THE WHIPPLE FAMILY OF ESSEX

Research to establish the origins and English ancestry of John Whipple of America continued based on the information provided by our previous report:

Captain John Whipple, who was said to have been born in about 1617/18, was an emigrant to America in about 1630. Bank's <u>Planters of the Commonwealth</u> states that he was a passenger in the Winthrop Fleet of 1630, but a John Whipple, carpenter, who is thought to be the ancestor, emigrated on the ship 'Lyon' which sailed from London on 2 June 1632 and arrived in Boston 16 November 1632. Also on board this ship, owned by the Vassall family of Eastwood Essex, neighbours of John Winthrop, was Matthew Whipple a presumed relative.

Matthew Whipple, born in about 1590, was the eldest son of Matthew Whipple senior a clothier of Bocking, Essex, whose will was proved in 1618. Matthew junior had a brother John baptised 29 August 1596 at Bocking. Both Matthew junior and John married and had sons named John: Matthew to Ann Hawkins in 1622 and John to Sarah Hawkins. Matthew's son John was born in about 1632 and became known as Lieutenant John; John's son John was baptised at Bocking on 21 December 1625 and became known as Captain John. There has thus been some confusion between Captain John the ancestor, thought to have been born in about 1617/18, and Captain John son of John, baptised in 1625; the two men are thought,

nevertheless, to have been related. The baptism registers of Bocking, where the ancestral John is supposed to have been baptised do not survive for the period 1606 to 1654 (apart from an incomplete transcript) and it is thought that relevant Whipple entries have therefore been lost.

From Founders of Early American Families by Meredith B Colket Jr (1975), we know that John the ancestor was of Dorchester, Massachusetts, by 1632; Matthew Whipple was of Ipswich, Massachusetts, by 1638 and his brother John was also of Ipswich, possibly by the same date, dying there in 1669. John the ancestor married Sarah They or Darling in about 1639 and died in 1685.

Searches for the baptism of John the ancestor in English records found that a John Whaples was baptised in 13 December 1618 at Great Waltham, Essex, the son of John Whaples senior and Mary formerly Collett who married on 19 January 1617 in the same parish. This family had been investigated in some detail and all Whipple and variant probates proved in Essex between 1549 and 1700 had also been examined. No firm evidence had emerged which proved beyond doubt that John baptised in 1618 was either the ancestor or related to the Bocking Whipple family.

Research recommenced by searching for Whipple wills proved in the Prerogative Court of Canterbury between 1630 and 1700 (appendix page 1). From this listing the details were abstracted from three wills of possible relevance:

The will of Margaret Wyvell did not mention any relatives named Whipple. The will of Thomas Whaplett showed that he was the owner of a tobacco plantation in Virginia. He mentioned an uncle Thomas and an unmarried sister Rebecca, but their places of residence in England were not stated. Thomas the testator appears to have lived in London prior to his emigration.

The 1657 will of Robert Whippe of Nazeing contained references to his brother Richard and Richard's unnamed children, as well as to a sister Ellen. During previous research the will, dated 1666, of an Ellen Whaples spinster of Colchester had been abstracted, as had the will of Ellen's brother James, a grocer of Colchester (proved in 1640). From these it was revealed that Ellen and James had brothers Peter (living abroad) and William, and married sisters Mary Chapman and Elizabeth Layer. Neither testator had mentioned brothers named Robert or Richard. We cannot therefore determine whether the Ellen mentioned in Robert's will is the Ellen whose will was dated 1666. No connection with the Bocking or Great Waltham families was established.

As John the presumed ancestor was baptised on 13 December 1618 at Great Waltham the son of John Whaples and Mary formerly Collett, our next step was to search for and abstract Collett wills, hoping that they might contain references to Whipple relatives. Beginning with the PCC indexes Collett entries between 1605 and 1660 were listed (appendix pages 6-8). It has been assumed, at this stage, that Mary Collett was from an Essex Collett family, although this may not have been the case. Only one Essex entry was found - the 1649 will of a Jane Collett of Corringham, Essex. Details

of the document were abstracted (appendix page 8) but no references were found to any Whipple relatives.

A search of the will indexes of the local Essex probate courts between 1617 and 1650 produced five Collett entries:

These wills were interesting as the Collett testators in four of the wills were also known as Daynish/Devonish(e). The will of Thomas Whaples proved in 1689, brother of John the possible ancestor, which had been abstracted in previous research (page 18 1988 report) had mentioned a house called Colletts and named a son-in-law John Davinish. Details of all the Collett wills were abstracted, and although none made any direct reference to Whipple relatives there were some tenuous connections found between the will of John Collett in 1646/7 and the previously abstracted will of Thomas Whaples. Collett alias Danish of Much Lyes, a husbandman, mentioned brothers Richard, Thomas and Andrew, Richard's son Edmond and a kinsman named John Miller. of Thomas Whaples had mentioned a house named Colletts, son-in-law John Davinish and grandchildren named Miller, Thomas's daughter Rebecca having married a Daniel Miller. We were, however, unable to determine the exact relationship between Thomas Whaples and John Collett/Danish. possible that Thomas Whaples inherited the house 'Colletts'

on the death of his father - the house either having come into the Whaples family through Thomas' wife Mary, or being known as 'Colletts' as this was Mary's maiden name. John Davinishe, who married Thomas Whaples daughter Mary, may have been a son or other relative of John Collett/Danish's brothers Richard, Thomas or Andrew. The Miller connection could not be established.

The will of Thomas Devinishe alias Collett dated 1639 was also of interest. No date was given for the probate of this will, and although it was written in 1639 it may be that of the Thomas Collett of Stondon Co Herford (sic) mentioned in the will of John Collett dated 1644, Thomas dying after this date. however, was said to be of Fowlness in 1639 rather than of Stondon, as in John's will; we cannot therefore assume that the two Thomases are the same. Fowlness mentions his sons Robert and Richard and indicates that Richard is living abroad, unfortunately without giving his actual place of residence. this will was that of John Collett's brother Thomas we had now found a Collett family, with a member living abroad, which was perhaps connected with the Great Waltham Whaples family. However there was still no proven link with either the Great Waltham or Bocking family.

Nothing further was learnt from the remaining Collett wills and attention was next directed to attempting to confirm John the ancestor's stated apprenticeship to Israel Stoughton. The source of this information was unknown, but further evidence of the link was now sought from printed sources and

Essex records. Bank's <u>Planters of the Commonwealth</u> states that members of the Stoughton family, like the ancestor John Whipple, were 'presumed to have been aboard ships in the Winthrop Fleet of 1630' and lists:

The Essex section of Boyd's Marriage Index was examined from 1538 to 1650 for Stoughton entries. Six were found, but the marriage of Israel and Elizabeth was not amongst them; neither was the marriage of Thomas noted. No Stoughton/Whipple marriages were found, although a Nathaniel Stoughton married in Bocking in 1633:

Following Bank's indication that the Stoughtons were of Coggeshall the registers of this parish were examined, as were those of Bocking and Great Waltham, for Stoughton entries. Great Waltham baptism registers examined 1595-1625 failed to contain any entries for the surname. Transcripts of the Coggeshall baptisms 1584-1630 were examined (1609-10 missing) and Israel's baptism plus other Stoughton entries were found:

Stoughton entries were also found in Bocking.

The baptism transcript registers examined from 1561 to 1605 (missing 1606-1654) failed to contain any Stoughton entries, but the marriage of Nathaniel and Maria was noted in 1633, as had been shown in Boyd's Marriage Index. The burials were searched 1558-1628 and five Stoughton entries were revealed: a Thomas Stoughton was buried on 20 October 1615 and four children of a William Stoughton were buried between 1616 and 1628. As stated in previous research apprenticeship records for Bocking do not survive for the period we are interested in - the earliest documents available dating from 1687 onwards.

Coggeshall apprentice records commence in 1718 - again too late for our purposes.

Assuming that the Stoughtons of Coggeshall and Bocking might be related, we next sought Stoughton wills from Essex, hoping to find such a connection and also a Stoughton/Whipple link. PCC will indexes were checked 1383-1700 (apart from the period 1661-1670); although some entries for the name were found, none was for Essex. The indexes of the local Essex courts were examined 1400-1700 and three entries revealed:

Details were abstracted of these wills (appendix pp14-15). Richard Stoughton of Amwell mentioned a niece Mary Lawrence. This surname also featured in the 1549 will of Jone Whippul of Bromefield who mentioned a Rose and Joanne Lawrence (1988 report appendix p7). However, although this may indicate a connection between these two wills, it may just be coincidence that the same surname appears. The wills of William and Isabel Stoughton were found to be those of husband and wife. Both mentioned Clayden and Sell grandchildren; neither of these surnames appear in any Whipple or Collett material so far examined.

As no definite evidence of the link sought had emerged in the searches of Essex records, research was next directed to American sources. Here we found that few definitive records exist relating to John Whipple of Dorchester. Without these it is almost impossible to find a link between the ancestral John and the Whipples of Ipswich.

From Whipple-Hill Families by John Whipple-Hill, Chicago 1897, it was learnt that John Whipple was born in about 1616/17. This information came from his tombstone, which records his age at death as 'about' sixty eight years in May 1685:

In Memory of
Capt. JOHN WHIPPLE
Who was born in England and died in Providencetown
The 16th May May, Anno Dona 1685
About 68 years of age

John received a grant of land at Dorchester in 1637 and this is borne out by the entry in Dorchester Town Records (City Document 9) 4th Report of the Boston Record Commissioners 1880, page 27:

2 Jan 1637 It is ordered than (sic) John Whipple shall have 8 akers of land granted him in full of all allottments to be layd out by Mr Stoughton & Mr Glouer about the mill as may be least p'juditiall to the plantation, this graunt being in reguard of a former p'mise upon record

Despite given information that 'after May 18 1631 persons who became freemen of the Massachusetts Bay Colony were required to be church members' no record has been found of the ancestral John becoming either a church member or a freeman. American research has found that the only Whipples recorded as being made freemen of the Commonwealth of Massachusetts (1631-1691) were John of Ipswich (13 May 1640 C.R. Vol 1 p.281 from Paige's List of Freeemen in Massachusetts); John Whipple of Ipswich (29 May 1668 C.R. IV 600): and Joseph Whipple of Ipswich (11 March 1674 C.R. IV 738). Neither is there any surviving record of John of Dorchester becoming a church member. However, according to Dorchester Church Records, Boston Commissioners Series page 7, John's wife Sarah 'Goodwife Whipple' joined the Dorchester Church on 29 August 1641, their eldest known child John being baptised at Dorchester shortly afterwards on 1 September 1641 (Op. cit. p172).

It was stated that John Whipple had married Sarah They or Darling between 1639 and 1640. New England

Marriages Prior to 1700, suggests that this marriage took place at Dorchester, but no record of the event has been traced. There is also no evidence to confirm that Sarah's maiden name was either They or Darling.

In fact neither surname appears amongst early Dorchester surnames. (There are however 'Thayers' - whether the name 'Sayer' found in the 1686 will of Thomas Whaples of Great Waltham, could be a later variant of 'Thayers' is not known.) Also questionable is the placing of Dorchester, in New England from Sarah's tombstone as her place of birth:

In Memory of
Mrs SARAH WHIPPLE
Wife of Capt. JOHN WHIPPLE
She was born in Dorchester, in New England
And died in Providence, Anno Dona (sic) 1666
Aged about 42 years

This tombstone gives Sarah's year of birth as about 1624. All records give 1630 as the date of the establishment of Dorchester. The settlement of Plymouth occurred, however, in 1620. Without evidence to contradict it there may be some likelihood that Sarah was born in New England, but it cannot be accepted as fact.

The evidence for the ancestral John being the brother of Matthew Whipple of Ipswich appers to have its origin in Pioneers of Massachusetts by Charles Henry Pope, 1909, page 491. Here it was claimed that John of Dorchester, a brother of Matthew of Ipswich, lived in Ipswich for a time before returning to Dorchester and then moving on to Providence, Rhode Island. This statement ignores the presence of John Whipple who died in Ipswich in 1669. The confusion

may have arisen because both John of Ipswich and John of Dorchester had wives named Sarah.

Further evidence of the Whipple/Stoughton link was also sought in American reocrds. The grant of land to John in 1637, laid out by Mr Stoughton, had been previously noted, and we also knew from Planters of the Commonwealth that Israel Stoughton, baptised in 1602/3 at Great Coggeshall, was in Dorchester circa 1630 with his wife and brother. The American Genealogist, Stoughton-Knight data, pages 105-112 (see appendix) gives comprehensive details of the Stoughton family. Briefly, Israel Stoughton was the son of Thomas Stoughton, Vicar of Coggeshall. Israel's mother is said to have died shortly after his birth, his father remarrying to an Elizabeth After the death of Thomas Stoughton, Elizabeth married again to a William Knight and had a son William Knight junior. son of William Knight junior became Vicar of Eastwood 1668-1673. Previous research had identified a Edward Whaples of Eastwood whose will proved in 1610 (1988 report appendix page 13) had mentioned a brother John and was witnessed by John Vassall, owner of the ship 'Lyon' on which the ancestral John had emigrated. Israel's will was dated London 17 July 1644 and amongst the executors were Governor John Winthrop and Mr Richard Saltonstall. Founders of Early American Families examined during previous research had shown that the ancestral John was an agent for Mr Saltonstall of Dorchester. Genealogical Gleanings in England includes the will of the Reverend John Stoughton, proved in 1639, said

to be the brother of Israel and Thomas, but this did not contain any information helpful to the research.

Whether the ancestral John was ever formally an apprentice or indentured servant of Israel Stoughton remains in doubt. He was certainly connected with him and Mr Saltonstall after his arrival in Dorchester. John was probably one of the emigrants recruited within Essex either by Israel Stoughton (who seems to have been one of the leaders of the new community, and was probably therefore closely associated with the Winthrop, Vassell and Saltonstall fmailies) or by the Reverend Thomas Hooker who was also instrumental in the recruitment of many of the emigrants.

Finally the names of John Whipple's children must have some significance and could of course be family names. The known children were named: John, Sarah, Samuel, Eleazer, Mary, William, Benjamin, David, Abigail, Joseph and Jonathan. While naming patterns should not be used alone to establish family relationships, they can be a useful guide to such connections. It is disappointing that we have not been able to trace any details of Sarah's family, as names from her family were probably amongst those given to the children. However, the most noticeable feature of the given names is the absence of the name Matthew - if the ancestral family was closely related to Matthew of Ipswich we might have expected to see this name being given to one of John's sons or later descendants. (The unusual forename Israel was given to the son of David Whipple, showing that family associations were probably considered when naming children.) The names John, Mary, William and Joseph

of he

do appear in the Great Waltham Whaples family, but these are widespread names and unfortunately no especial significance can therefore be attached to their use.

This phase of research has provided us with a little more information on the Great Waltham Whaples family and shown that the Collett(Davinish(e)/Whaples families were probably connected, even though no exact relationships, other than the marriage of Thomas Whaples and Mary Collett, can be discerned. of references in land deeds in America to the name Whipple, which might have enabled us to establish the surnames of neighbours and possible Whipple relatives in Dorchester, has hampered research in American records. Such information might also have enabled us to make a connection with the English families known to have members living abroad. We cannot rule out the possibility that the John Whaples baptised in 1618 at Great Waltham was the ancestor, but this cannot be substantiated; the non-survival of relevant parish material has also hindered this aspect of the research.

This research could be continued by examining more probate material and searching for further Collett/Davinish, Stoughton and Whipple wills beyond the county of Essex. Chancery records could also be consulted. However there would be no guarantee that we would be able to confirm the relevance of the 1618 baptism, or any other alternative baptism located.

WHIPPLE.

Captain JOHN WHIPPLE, one of the early settlers at Providence, R. I., was born in England about 1616 or 1617, and died May 16, 1685. What part of England he came from is not known. History states that in 1630 about fifteen hundred persons landed in Boston from Eng-"Oct. 3, 1632, he was ordered to pay 3s. 4d. to his master, Israel Stoughton, for wasteful expenditure of powder and shot." As he was apprenticed to Stoughton, it is only fair to suppose that he came to this country with In 1637, he received a grant of land at Dorchester He married his wife, Sarah, at Dorchester, about the year 1639-40, and they united with the church at Dorchester in 1641. He was a house-carpenter by trade, and owned a house and forty or fifty acres of land near Neponset village. He lived at Dorchester about eighteen years, and during that time there were born unto him six sons and two daughters.

He sold his house and land to James Minot in 1658, and removed to Rhode Island, settling at Providence, with his family, he received appropriation July 29, 1659. He had two sons and one daughter born at Providence, making in all eleven children. In 1660, he received a grant of land in Louisquisset. He also owned land in several other places, as mentioned in his will. February 19, 1665, he had lot 45 in the division of lands. May 31, 1666, he took the oath of allegiance to King Charles II, as did also his eldest son John. He was a member of the town-council of Providence, in 1669; town-clerk, 1670-2, 1676-7, 1681-3; town-treasurer, 1668-83; and deputy to the Rhode Island general assembly, 1666-9-70-2-4-6-7. He received a license to keep a public-house in 1674, at which place the town-elections were sometimes held.

In the year 1675, John Whipple was one among about twenty-five others who voted at a town-meeting to stay at Providence, instead of going to Newport, in the time of King Philip's War. Most of the inhabitants of the town availed themselves of the offer made them by their friends at Newport, and the town was nearly deserted. In 1676, Providence was attacked by Indians; many homes were burned and much damage done to the inhabitants. It is evident that he had to bear his part of the calamity. August 14, 1676, he had a share in the disposition of the Indian captives, whose services were sold for a term of years. March 2, 1680, an inn-license was granted him, and he is quoted as being one of the three most conspicuous inn-holders of the century. From the staid and sober character of the Whipple Inn, as well as from its central location, it became the favorite place of meeting for the town-council and court of probate. In 1690, the October session of the Rhode Island general assembly met at the Whipple Inn.

Captain Whipple lived in Providence about twenty-six years; during this period he experienced many hardships and privations, such as attend the first settlers of a new country; but among the many losses he had to meet, there could be none greater than the loss of his wife, who died in 1666, living with him only about seven years after they first came to Providence, and leaving in his care a family of several small children, the youngest an infant. He died May 16, 1685, and with his wife was buried in a garden-lot near his house. After several years, they with others of the family were reinterred at the North Burying Place. The following are the inscriptions on their tombstones:

IN MEMORY OF CAPT. JOHN WHIPPLE,

WHO WAS BORN IN ENGLAND, AND DIED IN PROVIDENCETOWN, THE 16TH DAY OF MAY, ANNO DONA 1685. ABOUT 68 YEARS OF AGE. IN MEMORY OF AND MRS. SARAH WHIPPLE,

WIFE OF CAPT. JOHN WHIPPLE,

SHE WAS BORN IN DORCHESTER, IN NEW ENGLAND;

AND DIED IN PROVIDENCE, ANNO DONA 1666.

AGED ABOUT 42 YEARS.

THE WILL OF CAPT. JOHN WHIPPLE, SEN .:

Be it known to all persons to whom this may come, that I, JOHN WHIPPLE, of the town of Providence, in the Colony of R. I., and Providence Plantations, in New England (Sen.), being in good measure of health, and in perfect memory, upon consideration of mortality, not knowing the day of my death, and having many children, and to prevent difference that otherwise may hereafter arise among them concerning my worldly estate, do see cause to make my will: and do hereby dispose of all my estate in this world, and do make my last Will and Testament.

I having formerly given unto three of my sons, all of my lands and meadows in Louquisset, namely:—Samuel, Eleazer, and William, equally to be divided among them three only; excepting thirty acres, which I gave unto my son John, at the North West End.

I give unto my three aforesaid sons, namely: Samuel, Elezer, and William, each of them, a quarter part of one right of Common, for pasturing, cutting of timber, and fire-wood.

I give unto my son Benjamin, a right of land in the late division which is already made out unto him.

I give unto my son David, a right of land in the late division which is already made out unto him.

I give unto my son Jonathan, twenty-five acres, on which he now dwelleth. Also, I give unto my son Jonathan, one division of land which is ordered by the town to be laid out between the "seven-mile line" and the "four-mile line," and papers already drawn for.

I give unto my son Joseph, my dwelling-house, and my three house-lots, and the garden next; also a six-acre lot lying on the southern side of the neck whereupon the town of Providence standeth; also twenty acres near Thomas Clemons, his dwelling;

also I give unto my son Joseph my share of meadow near Solitary Hill, and two six-acre lots, lying on each side of said Hill; also a six-acre lot, near William Wickenden formerly dwelt; also one division lying on the "seven-mile line," which is already ordered by the town and papers drawn for; also I give unto my son Joseph, all other divisions which shall hereafter belong unto two rights throughout.

I give unto my sons, namely: John, Samuel, Elezer, William, Benjamln, David, and Jonathan, these seven, twelve pence every

one of them.

I give unto my three daughters, namely: Sarah, Mary, and Abigail, unto every one of them, ten shillings. I give unto my son Joseph, all my right of land in the Narragansett country. I give unto my son Joseph, all my movable goods, of what sort soever, and all my cattle, and all my tools; also I do make my son Joseph my executor; also my will is that my son Joseph do see that I be decently buried; this being the real absolute Will and Testament of the John Whipple, Sen., as aforesaid, I do hereunto set my hand and seal, this eighth day of May, in the year one thousand six hundred and eighty-two.

I, Thomas Arnold, and John Arnold, the 27th day of May, in the year 1685, did upon these solemn engagements declare that they are witnesses unto the above will, and as these names are there written they do own it to be their hand.

Joseph Whipple did upon the 27th day of May, 1685, in the presence of the Council, as he is Executor to the Testator, upon his solemn engagement testify and declare that this is the last Will and Testament of his deceased father as ever yet perfected

as he knoweth of; and that he, when he made it, was of sound mind, and of a good memory.

On the back side of this Will it is endorsed as follows:

Thomas Olney, Town-Clerk of Providence, in the Colony of Rhode Island, and Providence Plantation, in New England, aged 53 years or thereabouts, testifieth that on the sixteenth day of this instant (May), John Whipple [Sen.] of the aforesaid town of Providence, sent for to speak with him.

This deponent saith he immediately went to him. John Whipple [Sen.] then showed him this paper, and the writing which on the other side of this paper is written, desiring this deponent to peruse it. This deponent saith he did well peruse it; and having well perused it, he asked the said John Whipple what his mind was concerning the land which he in the said writing had disposed of to his several sons; whether or no he did intend by that writing or Will that the said land should be unto his said sons, their heirs and assigns forever; or only onto his said sons for term of life? He immediately made this answer. That however it was not worded in the said writing, yet his mind and will was that his sons, each one of them, should have said house and rights which he in the said writing unto each one of them had disposed, to be unto them, theirs heirs and assigns forever, to dispose the same or any part thereof, at any time as they see cause; and that the same was omitted to be inserted. That his son Jonathan should have one of his rights of land and common, on the west side of the "seven-mile line" to be unto him, his heirs, and assigns forever; and that that was his mind when the said Will was written. However, it was omitted in part by the scribe of the said Will. There was an exception made only of thirty acres of land to be his son John's, by him formerly given. That he owned to be a mistake; and that the exception must be of sixty acres, which formerly by deed of gift he had given to his son John Whipple; and all the remainder of his said farm lying about Louisquisset should be divided equally between his said three sons [namely], Samuel,

Elezer, and William. This, saith this deponent, is truth; and he took it immediately from the said John Whipple's mouth and worded it down. And also that whereas the said Will expresseth a quarter-part of a right of common to each of his three sons [namely], Samuel, Elezer, and William; he said this meaning was and will, that it should be so far westward as the "seven-mile line," and no farther. And that the said John Whipple was then, when he did declare this, of a sound mind and perfect memory.

He lived in Providence until 1692, on the estate lest him by his father, when he bought land in the ancient limits of Rehoboth, now Cumberland, R. I. Rev. William Blackstone, one of the earliest settlers of Rhode Island, erected his study on a hill, and called the place "Study Hill." which name it still bears. This "Hill" at his death fell to his only son John, who deeded it to David Whipple. This deed is now in possession of the Historical Society at Providence. David Whipple, at the time of his death, was an ensign. His will is dated March 24, 1709, and proved January 8, 1711; his wife Hannah being the exccutrix. To son David he gives ten pounds, "he having had." To sons Israel, Jeremiah, and William, 1 s. each, as he had previously given them lands by deed. To wife Hannah, certain land for life, best bed, the rest of his household stuff, all money, cattle, and personal property. Inventory: purse, plate, and bills, £9 1s. 11d., wearing apparel, books, 5 beds, 2 great wheels, linen-wheel, 2 churns, 28 barrels of cider, half a cider-press, horses, cattle, goats, etc.

In 1715, the widow Hannah Whipple has order to receive £2 12s. 5d. upon the schoolmaster's account. She died in November, 1722. Her will is dated May 28, 1720, and proved December 8, 1722; executor, son Israel.

"To son Joseph Cowell, 10 pounds; to son Jeremiah Whipple, 20s.; to daughter Deborah Tower, a feather bed, chest, and half her wearing apparel; to daughter Sarah Razee, feather bed and half of wearing apparel; to four children, Israel and William Whipple, Deborah Tower and Sarah Razee, the rest." "Study Hill" went to Jeremiah Whipple, by deed before his father's death.

10. IX. ABIGAIL, born 1660; died August 19, 1725. She married first, Stephen, son of Gregory and Abigail

(Fullerton) Dexter, who was born November 1, 1647, and died 1679. Secondly, January, 1682, she married William, son of Thomas Hopkins, who was born in 1647, and died July 8, 1723.

- 11. X. JOSEPH, born in Frovidence, 1662; died in Providence, August 28, 1746, and was buried in the North Burying Place. He married, May 20, 1684, Alice, daughter of Edward and Auphillis (Angell) Smith, who was born in Providence in 1664, and died July 30, 1739. He, with his brother Jonathan, took the oath of allegiance to King Charles II, in May, 1682. He was a colonel of the Providence militia; was one of the town councilmen for twelve years, most of the time from 1715 to 1729; and representative to the general assembly for nineteen years, between 1698 and 1728. In 1723, he gave one hundred pounds toward building an Episcopal church on North Main Street, in Providence, it being the largest amount given by any one of those who contributed to its erection. He gave the use of a lot of land at the north end of Benefit Street to build a school-house on, and it was called "Whipple Hall."
- 12. XI. JONATHAN, was born in Providence, 1664, and died September 8, 1721. His first wife was Margaret, daughter of Thomas and Alice Angell. The second wife, Anna ———, died March 5, 1725.

STOUGHTON-KHIGHT DATA

By Genevieve Tylee Kiepura, of Soledad, California

The following records have been accumulated in the course of a search to prove, or disprove, the claim that the widow Judith Smead who died at Dorchester, Mass., in 1639, was sister of Israel Stoughton. The Court appointed him to be administrator of Judith's estate and, in his preliminary report, Israel called her "my sister." Cortain other items led me to question that she was his actual blood sister.

Stoughton

An article by Ralph M. Stoughton, supra, Vol. 27, pp. 193-204, states, "No records have been found that disclose the parentage and place of birth of Rev. Thomas Stoughton, father of Thomas and Israel Stoughton of New England." The following items, considered together, will supply that lack.

(1) The Alumni Cantabrigienses contains two accounts under Stoughton and Stockton which perhaps should be combined into a single account. These are as follows; the passages underlined by the present writer call attention to the similarity of the record:

"Stoughton or Staughton, Thomas. Matric. pens. from Trinity, Mich. 1573, B.A. from Queens 1576-7 as Stockton [footnote calls attention to account of William Knight]; M.A. 1580, Fellow of Queens (but see Stockton, Thomas, 1572); ord. Deacon and Priest (Lincoln) Feb.13, 1581-2; V. of Coggeshall, Essex (Stoughton) 1600-6.

Deprived."

"Stockton, Thomas. Matric. pens. from St. John's, Mich. 1572; B.A. 1576. Apparently Fellow at Queens 1579 'Stockton', but see also Stoughton, Thomas, with whom he may have been confused."

(2) Miscellanea Heraldica, Ser. 5, Vol. 5, p. 330:
The will of Thomas Stoughton of New Canterbury, Kent,
1591, named daughters Nethersole, Wilde, Faramour, and
"their children" (not named); brother Joel; sister 0mer; sisters Fuller and Cole; and nephew Thomas Stoughton of Suffolk and the two daughters of Thomas Stoughton the minister. (See our Note 1, below.)



(3) Visitations of Kent, 15/4, p. 35, and 1619, p. 18; Add. Mss. 5526, British Museum [see our Note 2].

Arms (Vis. 15/4): Argent on a chevron gules between four door staples sable, an escallop or, in dexter chief point a mullet of the last.

Arms (Vis. 1619): Quartered with Wilde: Argent on a saltire gules between four door staples sable, a cres-

cent in fess point or. [The pedigree is indexed "Stockton (Stoughton)." The John with whom it begins seems to be John (12) of the Stoughton pedigree in the Visitation of Sussex, p. $78.-\underline{G}.\underline{T}.\underline{K}.$]

(4) P. R. Planche in his Corner of Kent (Ash) states Moat Farm, as early as Queen Elizabeth's reign, was in the possession of the family of Stoughton. One of them Edward Stoughton of Ash, gent., whose will was proved in 1573, bequeathed to his son Joel, amongst other things, "the embroidering of a vestment set with 5,000 pearls or more, and 2,000 spangles and more of silvergilt upon the same." This Edward Stoughton of Ash was the great-grandson of Sir John Stoughton, Knight, Lord Mayor of London, whose second son, John Stoughton of Dartford, the grandfather of Edward, married before 1475, Jane, one of the daughters and co-heirs of Roger Clitherow, of Goldston, in Ash, by which marriage the estate of Little Betshanger, in Eastry parish, came to the family of Stoughton, from whom it passed first to Gibbs and then to Omer, with whom it remained until the

decease of Lawrence Omer, of Ash, when his only daughter and heir, Jane, brought it back to the Stoughtons by her marriage with Thomas Stoughton of Ash and afterwards of St. Martin's, Canterbury, son of Edward, of the Moat Farm aforesaid. Thomas Stoughton died in 1591 and left three daughters, his co-heirs, one of whom, named Elizaboth, married Thomas Wilde of St. Martin's Hill, Canterbury, Esq., and he alienated this estate of the Moat Farm to Mr. John Proude who resided here, as did his descendants, to the time of Charles the Second.

(5) The seal used by Gov. William Stoughton, and other members of his family, which is on his tombstone, is described: "On a saltire between four door staples a scollop" [Heraldic Journal, Vol. 1, p. 10; Vol. 2, p. 6]. Compare this with the arms in the Visitation.

(6) A further record; in the will of Elizabeth Walker, London, 1588, she mentioned "Mr. Stoughton, minister, of Suffolk." Nev. Thomas Stoughton at that time was at Naughton, Suffolk, ten miles from Ipswich where John Moore, father of Elizabeth Walker, lived.

Note 1: "The two daughters of Thomas Stoughton the Minister." There seems to be no record of the baptism of these daughters. The marriage records of Essex have the following and, judging by the dates and locations, the girls may well have been children of Rev. Thomas Stoughton:

1605, Mary Stoughton m. John Mansfield at Coggeshall [If the name could be read as Maxfield, these might be parents of Clement Maxfield who married Mary Denman, daughter of Judith Denman Smead.] 1607, Margaret Stoughton m. William Hulley at Felsted.

1613, Elizabeth Stoughton m. John Scudder at Malden Mary. [John Scudder of Barnstable was mentioned in the distribution of the estate of Judith Smead.]
1615 and later, William Stoughton had children, including son Thomas.

Note 2: The Stoughton Arms, given in Add. Mss., British Museum, do not agree with the Visitation of Kent, although the pedigree is the same, but are described: "Argent, a chevron sable, on a chief sable, two martlets argent."

Note 3: The Register of St. Paul's, Canterbury, has the baptisms of the children of Joel Stoughton, including a Thomas born 1584, too late to be the nephew Thomas named in the will of 1591. That seems to place Thomas, the minister, as the known son (Visitation pedigree) of Francis.

Note 4: There are no probate or land records in Kent indices naming Francis Stoughton. The <u>Visitation of Surroy gives Francis of Crayford, Kent, married Mary daughter of Anthony Malar of London (but lists no Thomas among his children), and says that Francis was son of Lawrence Stoughton of Stoughton [p. 85]. Since Crayford is only about three miles from Dartford, the home of Edward Stoughton, and Visitation records are known to contain occasional errors, attention is called to this Francis of Crayford as possibly the son of Edward.</u>

Note 5: We have discovered the marriage record of Israel Stoughton. The Registers of Rotherhite, Surrey, contain no baptismal or burial records of interest, but do contain the following marriage entries: 1627, Mar. 27: Israel Stoughton m. Elizabeth Knight.

1627, Mar. 27: Israel Stoughton m. Elizabeth Knight. 1638, Mar. 27: Edward Stoughton m. Alice Crooke. Rotherhite is a suburb of London. There are two other items of possible interest. In 1583 one Thomas Stoughton married at Christ Church, Newgate, London, Agnes Forste (the index of another parish register under the name "Forste" refers to "Forster"). In 1635 on the Truelove from the Port of London came Josias Forster, aged 43, listed directly under Edward Staughton, aged 50 [John Camden Hotten, The Original Lists, p. 87]. Did Edward return to England to marry, and was Josias Forster the nephew of the above Agnes and perhaps cousin of Edward?

Summary

1. The Visitations of Kent show the change of spelling from Stoughton to Stockton and back again. The account in Alumni Cantabrigieners shows matriculation of Thomas Stoughton at approximately the time when Edward Stoughton was spelling the name Stockton and calls attention to the confusion in the records.

2. The Visitation pedigree show Thomas son of Francis as nephew of Thomas [d. 1591]. The will of Thomas in 1591 calls Thomas Stoughton, minister, his nephew.

3. The arms described in the Visitation correspond

with those used by the Stoughtons of Dorchester.

Finally, at this writing, after four years of research in English records, including the help of professional searchers there, no indication has been found that there was a Judith Stoughton.

Knight

Israel Stoughton's own mother, Katherine, died shortly after his birth, at Coggeshall, Essex. We know that

he had a stepmother, Elizabeth, for the Alumni Canta-

brigienses had the following:

William Knight, adm. pens. of Emanuel, Jan. 31, 1626-7. he was the first son of William of St. Olave's, Southwark, and Elizabeth, widow of Rev. Thomas Stoughton (1576-7), matric. 1626-7; B.A. 1630-1; M.A. 1634; went to New England 1637 where he settled at Ipswich, Mass., and was for some years a preacher. Returned to England in 1643, with his half-brother [sic-G.T.k.] Colonel Israel Stoughton. Presented by Oliver Cromwell to St. Matthews, Ipswich, July 11, 1655. Canon of St. Mary's-at-Elms. Afterwards conformed. Ord. priest (Bishop Browning of Exeter) Aug. 8, 1659, and held his living until his death. Eur. at St. Mary's-at-Elms Jan. 6, 1696.

Beneath this is the account of his son, William Knight, adm. Sizer (age 17) at Pembroke Apr. 18, 1656, B.A. 1659, M.A. 1663, Vicar of Eastwood, Essex, 1668-73, Vicar of Stotfold, Beds., 1676-31; and then follows the account of his son, the third in direct line of

Cambridge graduates named William Knight.

The father of the first of these graduates was the William who married Elizabeth, widow of Rev. Thomas Stoughton. His will, 20 March 1629 [F.C.C., 38 Scrope], does not give his home, but "upon reference to the Probate Act he is described as of St. Olave's, fouthwark." "Debts to be paid and residue of my estate to be disposed by my wife Elizabeth. I give her her own 1/3 of my estate; the remaining 2/3 to be divided between my four children—William, John, Mary and Ursuly. I ordain my wife and my son-in-law Israel Stoughton sole executors." Oversoers, Robert rike, Edward Feach. Witnesses: William Knight, Richard Kendall. Note: the estate is not described in any way, either land or other types of property.

Since Israel Stoughton was stepson of Elizabeth, he would be described at that time as her son-in-law, and by extension he would be also "son-in-law" of her husband, William Knight. The term was then used both in this sense of stepson and also as husband of a daughter. The discovery (above) of the marriage of Israel Stoughton to Elizabeth Knight two years before the date of the knight will raises the question whether Israel did not stand in both relationships to William Knight. It would have been natural for William and Elizabeth Knight to have named a daughter Flizabeth; and despite the terms of the will and the expression "my four children," the will appears to be quite brief and it was not uncommon to omit reference to daughters who had already received their full portions. Hence we think it possible though not fully proved that Israel's wife was his

stepsister and an unrecorded daughter of William Knight. Should that theory prove untenable, then she was almost certainly a niece or other close relative. In any case some printed authorities, such as Alumni Cantabrigienses and Mr. Ralph M. Stoughton in his article cited above are inaccurate in describing Israel Stoughton as a half-brother of Rev. William Knight (d. 1696).

The above William Knight of St. Olave's (d. 1629)
has been confused with William Knight of Lincoln, whose will [P.C.C., 72 Scrope], of which I have a complete copy, dated 16 Nov. 1629 (four months before that of William of St. Olave's), named wife Lorothy but no children. Among others he bequeathed to William Knight, son of Richard Knight of Lincoln, late deceased, who might have been William of St. Olave's, but lengthy correspondence with Mr. F. E. Thurlby, Archivist at Lincoln, has convinced me that William of St. Olave's was not from Lincoln, as claimed.

was not from Lincoln, as claimed.

There are records of several William Knights residing in London at that time. The following line is giv-

en in the Visitation of London [p. 34]:

William Knight of Callis came from thence and placed himself in Kent. Two sons: Stephen ("martier in Q. Maries raigne burnt upon Maldon Marsh in Essex and died yssue lesse"); and John, see following.

John Knight of Kelvenden, Essex, mar. Ann daughter of Hevile of Raley, co. Essex, gent., and had: John, d. s.p.; Stephen, usher to King Charles I (living in 1634 and had Stephen, Mary and John); and Arthur,

see following.

Arthur Knight of London, mar. (1) Ellen Sadler, by who he had Arthur and William, both d.y.; mar. (2) Elizabeth Lechford, by who he had son Arthur, who d. s.p.; mar. (3) <u>Ursula</u> Salter of Whitechurch, daughter of William Salter by the dau. and co-heir of Oliver Carmin of ffenton Galham, co. Cornwall, and had children by her: Mary, d.y.; Arthur, eldest; <u>William</u>; Thomas; Nicholas; <u>William</u>; Samuel; and Katherine.

We have here two brothers named William knight whose mother was named Ursula, and William of St. Olave's named daughter Ursula in his will of 1629. While this is a possible clue, it may be that Arthur's sons by his third wife would be too young for identification with William of St. Olave's. I have made no effort to obtain the will of Arthur Knight. My object in checking Knight records was to see if William knight, who failed to name daughter Elizabeth in his will, might have had a daughter Judith, also not named, who might be Israel Stoughton's "sister" Judith Smead. I found no Judith Knight, nor baptismal records of any of William Knight's children.

The William Knight of Lynn, Mass., who died 5 March

1656, will dated 1653 [Hew England Hist. and Gon. Register, 5:253; 6:346] was not of course the brother-In-law of Israel Stoughton who died in England in 1676.

The will of Israel Stoughton, 1644, and extract of which was made for me by Miss Ruth E. Thomas of Boston, does not say "my users brothers Mr. William Knight, Mr. Thomas Stoughton, Mr. Thomas Clark and Mr. David Yale."
Israel named those four, among others, "to see to the due performance" but did not call them his brothers. He called Thomas Clarke "my deere brother" in his provision for his mother, whom he did not name ("Widow Knight"). Clark and Yale were presumably husbands of Israel's stepsisters, and quite likely his wife's brothers-in-law as well, but were not "half-brotherly connections." The repetition of the term "half-brother" In printed stories of this family is confusing, and in addition to the authorities cited is found in Appendix B of Samuel Eliot Morison's History of Harvard College in the Seventeenth Century.

If Judith Smead were Israel's own sister, why did he not take her young orphan son, William Smead, into his household and educate him? The boy was apprenticed. Judith's children are not mentioned in the Stoughton wills, not was the supposed sister, Ann Chamberlain. Neither Ann nor "Mother Knight" was listed among the people who were given Judith's possessions. There does not seem to be any emigration record, nor death or estate records, of the widow Elizabeth Knight. Did she remarry? One Elizabeth Knight married at Chelmsford,

Essex, in 1635, William Stileman.

At that period the terms "brother" and "sister" were often used loosely and applied to more involved relationships than that of actual brother and sister. So Israel's montion of Judith Smead as "my sister" needs better documentation.

Editor's Note. The discovery by Mrs. Kiepura of the marriage of Israel Stoughton to Elizabeth Knight is an important one. While preparing her article for publication above, a startling idea occurred to me. The late J. Cardner Bartlett supplied most of the material for the New Englanders in Venn's Alumni Cantabrigienses That is the chief source for the statement that Elizabeth wife of the elder William Knight had been widow of Thomas Stoughton. That may have been based on expressions of relationship used by Israel Etcughton and the identification of the "deere mother" provided for in his will as the widow Knight. It may therefore have been only a matter of interpretation that Israel Stoughton was elder half-brother of Rev. William Knight, and the older writers all seem to have believed that Ars. Elizabeth Knight was actual mother of Israel Stoughton.

That of course explains the constant use of the term "half-brother." When Mr. Ralph M. Stoughton discovered that the mother of Israel Stoughton was named Katherine and that she died shortly after his birth, the older supposition was not discarded, having gained the authority of Alumni Cantabrigienses, and it then became necessary to suppose the Elizabeth wife of William Knight was a second wife (and widow) of Rev. Thomas Stoughton, and that Israel's connection with the Knight family was merely a step-relationship.

With Mrs. Kiepura's added discovery that Israel Stoughton married Elizabeth Knight, all the terms of relationship found are accounted for without the supposition that William Knight married the mother or stepmother of Israel Stoughton. Rev. William Knight, and Thomas Clarke and David Yale, who married his sisters, all become brothers-in-law of Israel Stoughton by marriage.

In the accounts I have seen, I have failed to find any documentary evidence that the senior William Knight married the widow of Rev. Thomas Stoughton, or even that the latter did have a second wife Elizabeth. If such evidence exists, I shall be happy to learn of it and print it and also to withdraw my present suggestion. If there is no such evidence except the terms of relationship used in records, then these are adequately and more simply explained by the conclusion that Israel Stoughton's wife Elizabeth Knight was daughter of William and Elizabeth (——) Knight, and that she was omitted from his brief will because she was already married and had received her portion.

Since Mrs. Kiepura raises the question of mention of relationships in Israel Stoughton's will, it may be fair to quote from the very full abstract printed in 1850 in the New England Hist. and Gen. Register, Vol. 4, pp. 51-2. The will was dated London 1/ July 1644. This reads: "Wife & sonne Israel joint Executors, John Winthrop Senr, Mr. Thomas Dudley, Senr, Mr. Richard Bellingham, Mr. Richard Saltonstall & Mr. Increase Nowell, & also my deere brother Mr. Wm Knight, Mr. Thomas Stoughton, Mr. Thomas Clarke, Mr. David Yale overseers ..." It would seem from this abstract that Israel did intend the term "my deere brother" to apply not only to Rev. William Knight but also to his own brother Thomas and to Clarke and Yale who appear to have married the Knight sisters. In a sort of codicil he provides for "my deere mother," and in the event of his wife's death appoints "my deere brother Mr. Tho: Clarke" and two friends to act in her stead.

EDWARD WINSLOW, of London, Esq., being now bound in a "Viage" to sea in the service of the Common Wealth, 18 December 1654, proved 16 October 1655 by Josias Winslow, son and executor. All my lands and stock in New England and all my possibilities and portions in future allotments and divisions I give & bequeath to Josia, my only son, and his heirs, he allowing to my wife a full third part thereof for her life. To the poor of the church of "Plimouth" in New England ten pounds. To the poor of Marshfield, where the chiefest of my estate lies, ten pounds. I give my linen which I carry with me to sea to my daughter Elizabeth; and the rest of my goods which I carry with me to sea to my son Josias, he giving to each of my brothers a suit of apparell. Son Josias to be executor and Col. Venables my occaser of my goods in the voyage and my four friends, Doctor Edmond Wilson, Master John Arthur, Master James Shirley and Master Richard Floyd, to be overseers for the rest of my personal estate in England.

[Edward Winslow, the third governor of Plymonth Colony, was the son of Edward and Magdalen Winslow, of Droitwich in Gloucester, England, and was born Oct. 18, 1595. (See Register, xxi. 209-10, where his pedigree is given.) He was one of the Mayflower passengers. He was appointed by Cromwell one of three commissioners to superintend the expedition against the Spaniards in the West Indies, and died May 8, 1655, on the passage between Hispaniola and Jamaica. John Stoughton Doctor, in devinitie" & curate of the parish of St Mary Aldermanbury, London, beginning "Laus Deo the fewerth daie of May 1639" [on which day he died], proved 20 May 1639. To my poor kindred twenty pounds to be disposed of according to the discretion of my wife Jane Stoughton, one of my executors. To the parishioners of the parish of St Mary, Aldermanbury aforesaid five pounds, to be bestowed unto the poor of the said parish.

To my two daughters Jane & Marie five "hundreth" pounds, to say, to my eldest daughter Jane "fower hundreth marks which twoe hundred three score and six poundes thirteene shillings and fower pence, and the remainder beinge twoe C. hundreth thirtie three poundes six shillings and

eight pence to my youngest daughter Marie Stoughton, to be paied them att theire age of one & twenty yeares or the day of theire marriage, which shall first happen" &c. If both depart this life before they attain the age specified or day of marriage that then "two hundreth and fieftic poundes thereof shall come unto my wife and two hundred pounds thereof to my nexte of kynn, and twentie fine poundes thereof to Emanuell Colledge in Cambridge and the other five and twentie poundes to Master Hartlipp a Dutchman.'

To four or five persons such as my loving wife & one of my executors shall think fit twenty shillings apieco for a ring, provided Mr Janeway be one of them. The executors to be my dear and loving wife Jane Stoughton and my loving father in law and her father John Browne of Frampton in Dorsetshire Esq. and for overseers Robert Edwards and Edmond Foord of London merchants.

The remainder to my wife Jane Stoughton.

The Rev. John Stoughton was a brother of Israel and Thomas Stoughton, early settlers of Dorchester, Mass. Israel was the father of Lieut.-Gov. William Stoughton. Thomas removed from Dorchester to Windsor, Conn. Rev. John Stoughton, the testator, was also the stepfather of Gen. James Cudworth, of Scituate, New England, and of the Rev. 
LUKE HITCHCOCK (brother probably to Matthias Hitchcock, New Haven, 1639), place and time of birth unknown, took freeman's oath in New Haven, Ct., 1644, and soon after removed to Wethersfield, Ct.; in 1659 signed an agreement to remove to Hadley, Mass. He died Nov. 1, 1659, leaving a wife Elizabeth, probably sister of William Gibbons, of Hartford, Ct., and three children, as follows:
